Dear Kellie,

Re your letter dated xxxxx

As already stated to you in my previous written correspondence I DO NOT CONSENT to the installation of any smart meter on my property (xx addressxx) , due to my extreme sensitivity to electromagnetic radiation, which continues to impact my health and for which I have a doctor's medical certificate .

As you have previously acknowledged to me in writing that "there may be a pocket of the community who may represent hypersensitivity", this confirms that you are fully aware of this condition.

As you have recently written to me to say that you will "honour my request not to have a smart meter at this time" and that you have removed me from the smart meter installation program, I am at a loss as to why you continue to persecute and harass me and put stress on my family.

Your letter also refers to "any charges that may be incurred from 2015 for the costs of having a non-standard meter".

Can you please provide me with legislation that gives you the power to demand these charges from me.

Can you please provide me with actual figures of what these charges will be.

Can you please provide me with account details of what I have been charged so far for a smart meter which I do not have, nor want, nor have any intention of accepting.

Evidence is mounting that indicates that pulsed RF EMR is in fact hazardous to human health . Your document you sent me from the WHO (2005) is outdated. In 2011 the WHO classified RF EME as a Class 2B Carcinogen. For your company to ignore this is a failing in your duty of care to your customers to protect their ongoing health and safety and can be considered as a breach of section 98 (a) of the Electricity Safety Act 1998 which requires power Utilities "to design, construct, operate and maintain their networks to minimize as far as practicable hazards and risks to the safety of any person arising from the supply network. "

May I remind you of the legislation from the EEO Act ( Sect 44 & 45 ) relating to discrimination in the provision of goods and services and that you are required under that act to make reasonable adjustments for a person with a disability ( 45: 1a)

May I remind you that I have erected "NO TRESPASS signs on my property and I do NOT consent to you or any entity to enter my property for the purpose of installing a smart meter.

**May I remind you that you were charged by the Government to use your "best endeavours" regarding their mandate on YOU. At what point will common sense and common decency prevail and you leave us alone?**

**I have already suffered enough from your smart meters.**

**I have lost my health and quality of life.**

**I have lost my income.**

**I have lost my freedom to move in my community and the ability to move house if I so wish.**

**Simply relying on (hiding behind) ARPANSA'S unacceptable standards, which are outdated and obsolete and according to ICNIRP guidelines, (see page 546) on which these standards are based, acknowledge that they do not provide protection for "sensitive" populations and vulnerable people.**

**For United Energy to simply steam ahead and ignore the mounting evidence plus the cries and pleas from your customers who are reporting health problems is not only unethical but criminally negligent.**

**No one can say that smart meters are safe as these meters have never been formally tested in any health studies on humans ( except to say that we the people of Victoria are being treated as human guinea pigs in what can only be described as an experiment gone wrong)**

**As inconvenient as the situation is to you, the basic human rights, health and safety and respect of your customers should be your highest priority. We are talking about real people here who are suffering enormously because of this technology.**

**As the Government has confirmed that there will be two systems of metering, responsible and acceptable solutions should be discussed in consultation with your customers so that we can all get on with our lives.**
